

Call for a Research Fellowship within the scope of the Project no. 047130 - Classroom 4.0 - wellbeing resources

Reference: IE-ULisboa/07/BI/2022

An application for a Research Fellowship within the scope of the Project no. 047130 - Classroom 4.0 - wellbeing resources, funded by Program ESIF - European Structural and Investment Funds (Portugal 2020), through the Operational Programme for Competitiveness and Internationalization and the Regional Operational Programme Lisbon, under the following conditions:

1. Scientific Domain: Education, Design, Multimedia

2. Admission Requirements:

- Hold a Bachelor/Master degree in the area of Education, digital technologies, design, multimedia;
- Student enrolled in a cycle of studies leading to the PhD degree in the scientific areas of education, digital technologies, design, multimedia;
- Fluency of Portuguese and English spoken and written.

3. Preferential Requirements:

- Proven experience of research in the area of educational technologies and innovative educational environments;
- Proven experience in the areas of interior design, furniture and graphic design;
- Experience in using Autocad 2D/3D, Illustrator and InDesign software programs;
- Training in the use of quantitative data analysis software (e.g. SPSS);
- Training in the area of digital communication, image and marketing (preferably scientific content);
- **4. Work Plan:** The fellowship shall support the Project Classroom 4.0 wellbeing resources, which includes the following activities:
 - Support to the development of outputs under the Classroom 4.0 wellbeing resources Project, mainly in activities 1 (development of preliminary studies), 4 (support for the development of Tests and Pilot Study) and 5 (Data processing and structuring of new knowledge);
 - Support to the development of training and follow-up activities for teachers and classes, involved in the pilot study;

- Collaboration in the process of creating and disseminating the project outputs with different educational entities, as well as in the creation of digital content on innovative educational spaces;
- Support to activities associated with project management, execution of its Work Schedule and Promotion and Dissemination of Results Plan.
- **5. Applicable Legislation and Regulations:** Research Fellowship Statute, approved by Law No. 40/2004, of August 18th, in its current wording; Regulation for Research Grants of the Universidade de Lisboa, published in annex to Order no. 6238/2020, DR 2nd Series, no. 113, of 12th June 2020; FCT Regulation for Research Studentships and Fellowships, in effect.

- **6. Workplace:** The work plan will be carried out at the Instituto de Educação da Universidade de Lisboa (IE-ULisboa), under the scientific supervision of Neuza Sofia Guerreiro Pedro, Assistant Professor with Aggregation at IE-ULisboa
- **7. Duration and regime of the fellowship**: The fellowship will have a length of 12 (twelve) months, with a predicted start in April 2022. The fellowship may eventually be renewed, within the term of the project.

The tasks as a fellowship holder are carried out under an exclusive dedication regime.

8. Value of the Monthly Maintenance Allowance: The fellowship holder receives a Monthly Maintenance Subsidy (MMS) of €1 144,64 (one thousand, one hundred forty-four euros and sixty-four cents), according to the table of stipends of the fellowship awarded by FCT, I.P. in the country. The fellowship holder will benefit from personal accident insurance and, if he/she is not covered by any social protection scheme, he/she can ensure the exercise of the right to social security by joining the voluntary social insurance scheme, in accordance with the Code of Contributory Schemes of the Social Security Welfare System under the terms and within the limits set out in article 10 of the EBI.

- Fellowships Component Payments: The payments owed to the fellowship holders will be made through a bank transfer to the account provided by the holder or check.
- **10. Selection and Valuation Criteria:** The selection methods used will be based on the following parameters:
 - A Final classification obtained in the Bachelor/Master (25%);
 - B Experience in functions described in the work plan (25%);













C –Evaluation of the candidate's profile , according to the objectives of the project, considering the motivation, transversal knowledge in the area and availability demonstrated (50%).

The selection parameters will be assigned the following percentage weight:

$$0.25 \times A + 0.25 \times B + 0.50 \times C.$$

The selection parameters are valued on a scale between 0 and 20.

If necessary, only the three candidates with the best classification will be called to carry out the selection interview, which can be carried out by videoconference.

In this case, for candidates who pass the interview phase, the first evaluation component will weigh 60% and the interview will weigh 40%.

The interview grade will obey to the following criteria:

- a) Motivation for scientific research in general (25%);
- b) Specific motivation for the area of study to be carried out (25%);
- c) Knowledge in the area of study to be carried out (25%);
- d) Capacity of analysis and critical sense (25%).
- 10. Composition of the Selection Jury: The Jury was appointed by Order No. 12 of the Director of the Instituto de Educação of the Universidade de Lisboa (IE-ULisboa), 15 March, 2022, and is composed as follows:
 - Doutora Neuza Sofia Guerreiro Pedro, Assistant Professor with Aggregation at IE-ULisboa, President
 - Doutor João Manuel Nunes Piedade, Assistant Professor at IE-ULisboa, member
 - Doutora Elisabete Cruz, Invited Assistant Professor at IE-ULisboa, member
 - Doutora Nikoletta Agonács, Invited Assistant Professor at IE-ULisboa, Substitute Member













- **11. Publication/notification of results:** The final results will be published in a ranked list of final grades, in a visible, public location at the Instituto de Educação da Universidade de Lisboa, and published on the website www.ie.ulisboa.pt. The approved candidate will be notified by email.
- **12. Application deadline:** The application is open from **March 16th** to **March 29th** 2022.
- **13. Submission of applications:** Applications must be formalized, necessarily, through the following documents:
 - a) Application form, available at www.ie.ulisboa.pt;
 - b) Copy of the identification document (declaration of consent available at www.ie.ulisboa.pt);
 - c) Detailed Curriculum Vitae
 - d) Proof of enrolment for the academic year in a doctoral course1
 - e) Certificate of Qualifications²³,
 - f) Other documents that the candidates may consider relevant.

Remark 1: May be dispensed with during the application stage, being replaced by a declaration of honour by the candidates. Until the hiring stage, it is mandatory to present proof of enrollment in a PhD in the current academic year, in the scientific areas mentioned in the admission requirements.

Remark 2: The documents proving the completion of academic degrees or diplomas, or registration in a study cycle leading to the academic degree, may be dispensed with during the application stage, being replaced by a declaration of honour by the candidates. However, the verification of those documents will be mandatory if the fellowship is obtained.

Remark 3: The academic degrees obtained in foreign countries require recognition by a Portuguese Institution according to Decree-Law no. 66/2018, of August 16th, and Decree no. 33/2019, of January 25th. The presentation of such degree recognition is mandatory to sign the contract. More information can be found here: https://www.dges.gov.pt/pt/pagina/reconhecimento?plid=374. Under regular terms, if the recognition documents are not presented three months after the disclosure of the fellowship approval, the fellowship will not be granted.











14. Deadlines and procedures for complaints and appeals: If the decision is not favourable for the candidates, they have 10 days, starting from the date the results are disclosed, to make a statement in a prior hearing, under the terms of the Administrative Procedure Code.

The final decision may be appealed against to the Head of Instituto de Educação da Universidade de Lisboa up to 15 days after notification.
